- <u>Faculty deadline</u> Faculty and Specialists in CE (CA&ES and SOVM) must have their annual certification reports <u>completed and received</u> by the deans' offices *no later than November* **16, 2022**. However, Departments and Deans' Offices may set earlier deadlines.
- **Reminder** Faculty and Specialists in CE who are retiring or separating must also complete annual certifications before retiring or separating.
- <u>Deans' deadline</u> Deans' offices must complete their review and approval of faculty annual certification reports *no later than December 16, 2022*.
- <u>Financial Conflict of Interest (COI)</u> In addition to conflict of commitment, there are financial conflict of interest disclosure requirements that must be observed. Please review the notification for more details.
- <u>Deans' Responsibility</u> As a reminder, deans remain fully responsible for verifying that all approved requests for Category I activities (and approved requests for any other outside activities that may create a question of perceived or real conflict of commitment) meet the standards set forth in APM 025 and APM 671.
