Shared Governance is Important in the UC System

The Academic Senate:

- Determines the conditions for admissions and degrees
- Supervises all courses
- Approves the structure and content of all curricula
- Advises the Administration on faculty hiring, merits and promotions
- Advises the Administration on the budget
- Advises the Administration on any issue regarding the conduct and welfare of the University

Shared Governance is Important in the UC System

The Academic Senate operates at many levels:

- Schools and colleges elect their own Faculty
 Executive Committee, which is responsible for Shared
 Governance at a local level
- The Davis Division Academic Senate is responsible for campus-wide Shared Governance
- The UC Systemwide Academic Senate is responsible for systemwide Shared Governance

 - Authorizing broad use of virtual instruction
 - Allowing flexibilities in P/NP grading, drop deadlines, etc.
 - Working with the administration to make classrooms and research labs as safe as possible
 - Advising the administration as it deals with the COVID-19 financial crisis
